## Calgary Sports Car Club

### **Agreement With Respect to Access to the Calgary Sports Car Club Premises by Members of the Calgary Sports Car Club and by Members of the Calgary Amateur Radio Association**

I (Print Name) ..... do hereby confirm that I am a Member in good standing of the Calgary Sports Car Club ("CSCC") and / or the Calgary Amateur Radio Association ("CARA"), and do hereby make application for a Door Access Key Fob, hereafter referred to as the 'Key Fob', to enable access to the premises of the Calgary Sports Car Club ("CSCC") at 4215 – 80<sup>th</sup> Avenue N.E., Calgary, Alberta.

This agreement outlines the responsibilities I have as a holder of a Key Fob. My signature acknowledges that I understand and accept these responsibilities and that I agree to adhere to the protocol and procedures established for Key Fob usage as follows.

The Key Fob is the property of CARA and CARA reserves the right to withdraw, without prior notice, any or all such Key Fobs, or replace the Key Fob with one or more alternative methods for access to the premises.

The Key Fob is issued in my name and I am the only person authorized to use it to access areas of the Calgary Sports Car Club that I am entitled to by virtue of my specific club membership. Further, I will not allow any other person to use my Key Fob.

Duplication of the Key Fob or unauthorized use of the Key Fob, including permitting others to gain unauthorized access to the Calgary Sports Car Club using the Key Fob, is considered misappropriation of access privileges. This will result in immediate and irrevocable forfeiture of the Key Fob and my access privileges to the Calgary Sports Car Club.

I have the privilege to allow a Non-Member to access to the building as my Guest provided the Guest is accompanied by me. I acknowledge that I am responsible for the behaviour of my Guest and further that my Guest is required to leave the premises immediately if another Member, who is present at the time, deems that the Guest's behaviour is inappropriate. Further, CARA reserves the right to apply disciplinary sanctions against me for the behaviour of my Guest. Notwithstanding the privilege, CARA reserves the right to refuse access to any individual for any reason.

I accept that CARA records and maintains data regarding my personal use of the Key Fob. I understand that CARA may use video surveillance at the Calgary Sports Car Club's premises and grounds to protect the safety of its Members and to ensure appropriate use of its Property and to discourage theft and / or identify criminal activity.

If the Key Fob is lost or stolen, I agree to immediately contact the President of the CSCC or the President of CARA and report the loss. I understand that if CSCC and / or CARA issues me a replacement Key Fob, that I will be pay a new deposit of ten dollars (\$ 10.00).

I must continue to be a Member in good standing of CSCC and / or CARA and may be asked to provide evidence of such membership. Failure to maintain my membership in good standing will result in access to the CSCC premises being revoked and the immediate surrender of my Key Fob to a duly authorized representative of CSCC or CARA.

I have paid to CSCC and / or CARA a deposit of ten dollars (\$ 10.00) which is refundable upon surrender of the Key Fob, in good working condition, to a duly authorized representative of CSCC and /or CARA.

I acknowledge that I have read, understood and agreed to this agreement and have received a Key Fob.
